

## WHAT TO DO NEXT

There are a number of ways in which you can leave a charitable gift. These could include a chosen amount, trust arrangements, shares, annuities, residuary bequests and gifts of items which we can turn into funds. Leaving a legacy is a very flexible way of making a gift to charity without the risk of leaving yourself or your family out of pocket.

You can get free and independent advice about making a will from organisations like Citizens Advice and Age Concern.

It is a good idea to use a solicitor, or have a solicitor check a will that you have drawn up, to ensure that it's valid and that your wishes are carried out.






**The Rosemary Foundation

The Rosemary Foundation provides support and care for people with life threatening illnesses, who wish to remain at home as life draws to a close. A registered charity, we rely solely on donations.

#### WE PROVIDE

- A nurse to introduce the service and to implement a plan of care that expresses the wish of each patient
- Care and support that is available 24 hours a day, seven days a week.
- A team of nurses who visit regularly and are known to the patient.
- Emotional and counselling support available for patient and family that continues through to bereavement.
- A service that is entirely without charge to patient or the family.
